

AB7 Giveaways Official Rules 2022

PREAMBLE

AB7 America (hereinafter referred to as the "Sponsor"), whose head office is located 14073 NW 8th Street, Sunrise FL, 33325, USA, is organizing Giveaways with no purchase necessary (hereinafter referred to as the "Giveaway"), according to the terms and conditions described in these Official Rules.

The Giveaways are in no way sponsored, endorsed or administrated by or associated with Facebook, Instagram nor any other social media platform.

Entrants/Winners provide their information to the Sponsor and not to Facebook, Instagram nor other social media platform.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE ENTRANTS' CHANCES OF WINNING.

ART. 1 – AGREEMENT TO OFFICIAL RULES

Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Giveaways.

Winning a prize is contingent upon fulfilling all requirements set forth herein.

The Giveaways are subject to all applicable federal, state, and local laws and regulations and are void where prohibited.

The Sponsor reserves the right at any time, without notice, to amend, modify, or change these Official Rules, and to postpone, suspend or cancel this Giveaway and any prizes (which have not yet been subject to a draw), or any aspect thereof, without notice at any time, for any reason which the Sponsor reasonably deems necessary.

ART. 2 - ELIGIBILITY

The Giveaway is open only to:

- legal residents of the USA,

- who are at least eighteen (18) years old or have reached the age of majority in their respective state of residence as of the date of Entry,
- having a valid Facebook and/or Instagram account
(hereinafter referred to as the "Entrant").

ART. 3 – ENTRY CONDITIONS

- go to the dedicated post,
- Follow the entry instructions detailed in the dedicated post,
(hereinafter collectively referred to as the « Entry/ies »).

Entry is only effective after these steps have been completed. Any Entry of any other nature or form (on plain paper, by mail, by telephone, automated entries or any other form whatsoever) is void.

Sponsor is not responsible for any Entry that is lost, late, illegible, stolen, incomplete, invalid, unintelligible, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Proof of submission will not be deemed to be proof of receipt by Sponsor.

Entrant must be the owner of the email account associated with the Facebook or Instagram account from which the Entry is made.

Unlimited Entries per person. One comment = one Entry.

ART. 4 – DATES OF GIVEAWAYS

The Giveaways begin at 12:00:01am Central Time (“CT”) and ends at 11:59:59pm CT on the period indicated on the dedicated post (the “Giveaways Period”).

Sponsor’s clock is the official clock for the Giveaways.

All Entries must be received during the Giveaways Period in order to be eligible.

ART. 5 – DRAWING

The winner(s) will be selected in a random drawing from all valid Entries received, subject to verification and compliance with these Official Rules. The random drawing will be held on the date set forth in the dedicated post by Sponsor, without exceeding seven (7) days following the expiration of the Giveaways Period.

Odds of winning a prize will depend on the total number of valid Entries received throughout the Giveaway Period. Limit one prize per Entrant.

Sponsor reserves the right to disqualify from the Giveaways any Entrant it believes has violated these Official Rules and verify eligibility of Entrants.

ART. 6 – WINNER NOTIFICATION

The winner(s) will be notified by Sponsor via:

- Private message on Facebook, followed by Facebook announcement when entry has been registered on ALZOO Facebook page, or
- Direct message on Instagram, followed by Instagram announcement when entry has been registered on ALZOO Instagram page,

within five (5) business days of the random drawing (hereinafter referred to as the « Notification »)

The winner(s) must respond to Notification within two (2) business days of Notification and provide all requested information for delivery, which may include, without limitation: first name and last name, complete mailing address, e-mail address and phone number, date of birth.

In the event the winner (i) fails to respond to the Notification within two (2) business days of Notification or (ii) does not provide Sponsor with requested information within two (2) business days of Notification or such information is incomplete or erroneous or (iii) if it is determined by Sponsor that the winner is not eligible in accordance with these Official Rules, an alternate winner will be selected at random from among the remaining non-winning valid Entries received during the Giveaway Period.

ART. 7 – PRIZE DELIVERY

Winner(s) will be shipped their prize to the address indicated by winner within two (2) weeks from winner complete response to Notification and verification by the Sponsor.

In the event the prize is returned, the address is insufficient or incomplete for shipping purposes, or undeliverable for any reason, the winner will be disqualified and an alternate winner may be selected from the remaining valid Entries received.

No compensation will be provided for any prizes that are not able to be awarded to a winner.

ART. 8 – PRIZES

The number of winners and prizes that will be awarded is indicated in the dedicated post.

Total approximate retail value of all prizes does not exceed \$500. Winner is responsible for federal, state and local taxes, if applicable.

In the case of unavailability of any prize, Sponsor reserves the right to substitute a prize of equal nature and value.

All prizes are non-transferable and no substitutions or cash redemptions.

Sponsor is not responsible for any late, lost, stolen, damaged, delayed or undelivered prizes.

ART. 9 – PUBLICITY

The Sponsor may require the winners to be identified, photographed and published in printed media, or to appear on network media, when accepting their prizes or after having received their prizes.

By participating in the Giveaways and/or accepting the prize, the winner grants Sponsor the perpetual right to use his/her name, Instagram and/or Facebook Handles, biographical information, photos, and/or likeness, and statements for promotion, trade, commercial, advertising and publicity purposes, at any time, in all media now known or hereafter developed, worldwide including, but not limited to, on the World Wide Web and Internet, without notice, review or approval and without additional compensation, except where prohibited by law.

The winners will be given the opportunity to decline to the publication of their name and images.

By participating, Entrant consents to Sponsor's use of its personal information for the administration of the Giveaways.

ART. 11 – GENERAL CONDITIONS
